

## 1 $\mu$ A I<sub>Q</sub>, 250mA Low-Dropout Linear Regulator

### ***Purpose***

The RT9073A is a low-dropout (LDO) voltage regulators with enable function that operates from 1.2V to 5.5V. It provides up to 250mA of output current and offers low-power operation in miniaturized packaging.

The features of low quiescent current as low as 1 $\mu$ A and almost zero disable current is ideal for powering the battery equipment to a longer service life. The RT9073A is stable with the ceramic output capacitor over its wide input range from 1.2V to 5.5V and the entire range of output load current (0mA to 250mA).

## Introduction

### General Product Information

The RT9073A is a low quiescent current linear regulator designed especially for low external components system. The input voltage range is from 1.2V to 5.5V. The RT9073A builds in a P-MOSFET output transistor which provides a low switch-on resistance for low dropout voltage applications.

The Error Amplifier compares the internal reference voltage with the output feedback voltage from the internal divider, and controls the Gate voltage of P-MOSFET to support good line regulation and load regulation at output voltage.



### Test Points

The EVB is provided with the test points and pin names listed in the table below.


Test point/ Pin name	Signal	Comment (expected waveforms or voltage levels on test points)
<b>VOUT</b>	Output voltage	Default output voltage = 3.3V.
<b>GND</b>	Ground	Ground.
<b>EN</b>	Enable	Enable Control Input.
<b>VIN</b>	Input voltage	Input voltage range = 1.2V to 5.5V.

### Power-up & Measurement Procedure

1. Connect input power ( $1.2V < V_{IN} < 5.5V$ ) to VIN test pin.
2. VIN/VOUT placed 1 $\mu$ F capacitor.
3. Observe the output voltage is correct.


**EVB Schematic Diagram**




